Sub: Issuance of Letter of Intent for Establishment of a new Technical Institution namely Faculty of Engineering as a part of Integrated Campus with Multi-Discipline in the name and style of Marathwada Shikshan Prasarak Mandal's Group of Institutions, Station Road, Aurngabad (M.S.) – 431005, for the academic year 2009-10.

This is with reference to your application submitted to the All India Council for Technical Education (AICTE) for establishment of new technical institutions in Engineering & Technology/ MBA as part of Integrated Campus with Multi-Discipline.

The proposal has been processed as per the procedures, guidelines, policies and norms and standards of AICTE and I am directed to convey the decision of the Council to issue the letter of Intent (LOI) for the establishment of new Engineering & Technology institution as Faculty of Engineering as a part of Integrated Campus with Multi-Discipline in the name and style of Marathwada Shikshan Prasarak Mandal's Group of Institutions, Station Road, Aurngabad (M.S.) — 431005. This Letter of Intent will be valid for three years from the date of issue. This Letter of Intent issued under Development of Integrated campus with New Multi-Discipline Institutions is not valid for establishment of new stand-alone technical institutions. The norms and standards and conditions for Integrated Campus with Multi-Discipline are enclosed at Annexure - A.

To facilitate further processing of the proposal for grant of approval, you are required to furnish the following documents at the respective Regional Office, AICTE, and your proposal would be processed subsequently.

- A registered undertaking on non-judicial stamp paper of not less than Rs. 100/- duly notorised stating that the Institution shall abide by all the Regulations, Guidelines, Norms and Standards of the Council as applicable from time to time.
- A Joint Fixed Deposit created for a period of 8 years in the name of the President/Chairman of the Applicant Society/Trust and the concerned Regional Officer of AICTE for an amount as applicable separately for each category of the institutions proposed to be part of the Integrated Campus indicated below (Government and Government Aided Institutions and Government University are exempted):

- The original Joint Fixed Deposit receipts shall be kept under the custody of the applicant Society / Trust. A copy of the Joint Fixed Deposit receipts shall be submitted to the concerned Regional Office of the AICTE along with an affidavit on Non-judicial stamp paper of prescribed value duly notarized stating that the Joint Fixed Deposit shall not be encashed or modified without prior consent of AICTE. The Regional Officer AICTE shall also instruct the concerned Bank not to allow any encashment / modification of fixed deposit and grant of loan against the deposit without the prior consent of AICTE.
- > The interest accrued on the Fixed Deposit will be credited to the concerned authority of the Integrated Campus on yearly basis and shall be utilized for award of scholarships to the students.

- > The Joint Fixed Deposit shall be permitted to be encashed on expiry of the term of the Fixed Deposit. However, the term of the fixed deposit could be extended for a further period as may be decided on case-to-case basis and / or forfeited in case of any violation of norms, conditions and requirement and / or non-performance by the institution and / or complaints against the Integrated Campus.
- > A non-refundable visiting fee of Rs. 80,000/- in favour of "The Member Secretary, AICTE" on any nationalized bank payable at New Delhi for the whole Integrated Campus and not for each individual institution.
- The applicant society/Trust needs to indicate its readiness for Expert Committee visit by 31st May, 2009 for further consideration of the case for issue of Letter of Approval (LOA) for the current academic year i.e. 2009-10.

Your proposal will be processed only on fulfillment of the conditions mentioned above.

Subject to the fulfillment of all the conditions mentioned above, an Expert Committee visit shall be arranged by the Council for verification of the facilities required for Development of Integrated Campus in one go for all the New Multi-Discipline Institutions.

The Visiting Expert Committee will verify the original documents and all the necessary infrastructure, facilities, faculty etc. required for the above referred technical Institution as a part of Development of Integrated Campus with New Multi-discipline Institutions as per norms, standards & guidelines of the Council as stated below and also mentioned in the expert committee visit report.

- > Original land documents along with Khasra Plan etc. to check contiguity of land.
- Land Conversion / Use Certificate for the entire land.
- The site plan for the proposed land in relation to the adjoining built up structures, road etc.
- The approved building plan with exclusive individual institution-wise built up area with proposed phase-wise plan of construction. Availability of clear-cut earmarked built up space for each faculty of the Integrated Campus with a resolution of the Society / Trust earmarking the built up space.
- > An approved Master plan of the Integrated Campus. The Plan should clearly indicate the survey numbers of the land area.
- Whether the land of the proposed Integrated Campus including the Institution has been fully developed with clear demarcations, either by a boundary wall / barbed wire fencing and all weather approach road to the Campus.
- Whether the building is complete in all respects including plastering, internal electrification and effective conduct of classes etc. at least adequate for first year of the programme.
- Whether Permanent electrical and potable water connections exist.
- Whether all the required furniture and fixtures are in place as per requirements.
- Whether books and Journals, as per Norms and Standards, have been procured, stamped and entered in the Accession Register.
- Whether equipment, as per syllabi of first year, has been procured and is ready for use.
- Whether copy of advertisement for recruitment of faculty, composition and proceedings of selection committee meetings are available.
- Whether Director for the integrated campus and Dean / Associate Director for the concerned Institution have been appointed, and teaching faculty for the concerned faculty identified and their consent letter for joining obtained.
- Whether adequate operational funds as per AICTE norms are available in the form FDR/ Savings Account/Current Account in the name of the Society/Trust for the institutions run by the Trust.

- 2. The approval is valid for two years from the date of issue of this letter. The Society/Trust/Institution shall obtain necessary affiliation/ permission from the concerned affiliating University as per the prescribed schedule of the University/Admission Authority etc. The Applicant Society/Trust/Institution shall send information about commencement of the above courses to AICTE. Incase, the Institution fails to commence the above mentioned courses for whatsoever reasons during the two years period from the date of issue of this letter, the approval shall automatically become invalid and the applicant society/trust shall have to make a fresh application to AICTE for grant of a fresh approval.
- The approval is further subject to fulfillment of following conditions.
- i. That the management shall provide adequate funds for development of land and building and for providing related infrastructural, instructional and other facilities as per Council's norms and standards laid down, by the Council from time to time and for meeting recurring expenditure.
- That the admissions shall be made only after adequate infrastructure and all other facilities are provided as per norms and guidelines of the AICTE.
- iii. That the admissions shall be made in accordance with the regulations notified by the Council from time to time.
- iv. That the admissions to the courses shall be made only after the affiliating University (University under whom ambit the institution is functioning / State Board gives permission to start the course.

- That no excess admissions shall be made by the Institution over and above the approved intake under any vi. circumstances.
- That the institutions shall not have any collaborative arrangements with any Indian and/or Foreign Universities vii. for conduct of technical courses other than those approved by AICTE without obtaining prior approval from AICTE.
- That the Institution shall not allow conduct of any unapproved course whether technical or non technical in the viii. premises of AICTE approved institution/campus and /or in the name of the Institution without prior permission from AICTE.
- That the institution shall operate only from the approved location, and that the institution shall not open any off campus study centers/ extension centers directly or in collaboration with any other institution/ university/ organization for the purpose of imparting technical education without obtaining prior approval from the MCTP.
- That the tuition and other fees shall be charged as prescribed by the Competent Authority within the overall criteria prescribed the Council from time to time. No capitation fee shall be charged from the students/guardians of students in any form,
- That the accounts of the Institution shall be audited annually by a certified Chartered Accountant and shall be xi. open for inspection by the Council or any body or person authorized by it.
- Director: A Integrated Director may be appointed from any of the disciplines/subjects of technical xii. education being offered in the Campus as per the norms and guidelines laid down for eligibility and selection procedure.
 - Faculty: The Integrated Faculty should be available in each institution as per the existing norms. (b)
 - Non-Teaching staff: The Non Teaching staff should be available as per the existing norms in each institution. A Registrar/Chief Administrative Officer should be appointed to look after administrative activities of the entire campus. A placement Officer should also be appointed to look after the placement activities of all the Institutions located in the Campus.
 - Other Campus facilities: A common Canteen, common Sports facility and Auditorium etc. may be developed in the Campus for the benefit of students of all the Institutions located in the Campus
 - That all the laboratories, workshops etc. shall be equipped as per the syllabi of the concerned affiliating University /University under whose ambit the institution is functioning, and shall be in operational condition before making admissions.
 - A Central Library covering all the subjects of various institutions located at the same campus with separate libraries located in respective institution/departments is required to be provided. The total no. of books, volumes and journals should be the sum of all the requirement of department/institutions together as per AICTE norms.
 - A Central Computer Center for various institutions located at the same campus with (g) departmental/institutional computer centers located in respective institutions/departments is required to be provided. The no. of computers required are rationalized and the computer student ratio be relaxed up to 1:6.adequate number of terminals, Printers, legal software etc. shall be established as per AICTE norms.

That the institution shall furnish requisite returns and reports as desired by AICTE in order to ensure proper xiii. maintenance of administrative and academic standards.

- xiv. That the technical institution shall publish an information booklet before commencement of the academic year giving details regarding the institution and courses/programmes being conducted and details of infrastructural facilities including faculty etc. in the form of mandatory disclosure. The information booklet may be made available to the stakeholders of the technical education on cost basis.
- xv. That it shall be mandatory for the technical institution to maintain a web-site providing the prescribed information. The website information must be continuously updated as and when changes take place.
- xvi. That a compliance report in the prescribed format along with mandatory disclosure on fulfillment of the above conditions, shall be submitted each year by the Institution within the time limit prescribed by the Council from time to time.
- xvii. That if Technical Institution fails to disclose the information or suppress and/or misrepresent the information, appropriate action could be initiated including withdrawal of AICTE approval.
- xviii. That a Joint FDR is required to be created for an amount and period prescribed by the Council separately for each institution for from time to time.
- xix. That AICTE may carry out random inspections round the year for verifying the status of the Institutions to ensure maintenance of norms and standards.
- That the AICTE may also conduct inspections with or without notifying the dates to verify specific complaints of mis-representation, violation of norms and standards, mal-practices etc.
- xxi. That the Institution by virtue of the approval given by Council shall not automatically become claimant to any grant-in-aid from the Central or State Government.
- xxii. The Institute shall take appropriate measures for prevention of ragging in any form, in the light of directions of Supreme Court of India in Writ Petition No. © 656/1998. Incase of failure to prevent the instances of ragging by the Institutions, the Council shall take appropriate action including withdrawal of approval.
- xxiii. That the Management shall strictly follow further conditions as may be specified by the Council from time to time.
- xxiv. That the Institution shall provide the following facilities for the physically challenged persons.
 - a. Class rooms, toilets and hostels to be made accessible to wheel chair users.
 - b. Resource room for visually impaired students.
 - c. Accessible Library
 - d. Counseling Centre for disabled students
 - e. Facility of Sign Language Interpreter
 - f. All students needing assistive devices to be provided such devices
